Public Comments

Treasurer's Report - Morgan reported the DDA has approximately \$156,639 cash on hand. Invoices presented were Dickinson True Value Hardware for supplies, Ken Holewczynski for web site re-design, Maple Net Wireless for Wi-Fi repair services, National Tool GR, Inc. for streetscape delineators, and Lisa A. Sheaffer for contracted services. Rastall moved, supported by Cook to approve the additional \$700 quoted by Ken Holewczynski for web site redesign. MOTION CARRIED. Rastall moved, supported by Cook, to approve the bills, totaling \$2,398.63, as presented. MOTION CARRIED.

Old Business

- A. Website Design Sheaffer stated that the DDA needed to purchase web hosting for the web site. Morgan moved, supported by McCracken, to purchase a web hosting plan from Go Daddy with a cost not to exceed \$8 per month. MOTION CARRIED.
- B. Vacant Board Position Both Linda Barnes and Ed Kortman expressed an interest to serve on the DDA Board. Rastall moved, supported by Morgan, to appoint Ed Kortman to the DDA Board. MOTION CARRIED UNANIMOUSLY.

New Business

A. Christmas Trees and Wreaths Sales Request - The Boy Scouts of America requested to sell Christmas trees, wreaths, and other items at the DDA property on Main Street across from the Hutchinson Garden on weekends beginning November 30th and ending December 22, 2013. Rastall, moved, supported by Cook, to allow the Boy Scouts to sell Christmas trees, wreaths, and other items as requested. MOTION CARRIED.

- A. Economic Restructuring Cook reported on the status of the grant. Letters of support need to be solicited. Ramos reported on the meeting regarding economic development and the upcoming holiday celebration.

- E. Goose Festival Welscott gave the financial report of the 2013 Goose Festival. There may be a change in the carnival/food provider for next year's carnival. The next meeting is November 13th. The committee received some unexpected expenses such as a bill from the City for putting up the banners. Cook moved, supported by Schrock, to pay for the cost of putting up the Goose Festival banners. MOTION CARRIED.
